ADMISSION REQUIREMENTS

The following are admission requirements for graduate studies at the University of Cambodia.

MASTER’S DEGREE

In order to be considered for a Master’s degree program, an applicant must:

- 1) have a Bachelor’s degree from a recognized university or institution,
- 2) pass the Graduate Entrance Examination and the Graduate English Placement Test

Note: The Graduate English Placement Test may not be required, if students have one of the following:

- a) a valid ITP TOEFL score of at least 500 or an iBT TOEFL score of 70;
- b) a valid IELTS score of at least 5.5;
- c) a Bachelor’s degree from a university in which English is the language of instruction.

DOCTOR OF PHILOSOPHY DEGREE

In order to be considered for a Doctoral degree program, an applicant must:

- 1) have a Master’s degree from a recognized university or institution;
- 2) pass the Graduate Entrance Examinations and the Graduate English Placement Test

Note: The Graduate English Placement Test may not be required, if students have one of the following:

- a) a valid ITP TOEFL score of at least 500 or an iBT TOEFL score of 70;
- b) a valid IELTS score of at least 5.5;
- c) a Bachelor’s degree from a university in which English is the language of instruction.

GRADUATION REQUIREMENTS

In order to be able to graduate, graduate students have to meet the following requirements:

MASTER'S DEGREE STUDENTS

The Thesis Option

1. Complete a minimum total of 14 courses (42 credits)
2. Pass each course with at least a grade B (only three grade Cs are allowed)
3. Maintain a minimum overall GPA of 3.0
4. Complete a Master's Thesis (12 credits)
5. Defend the Master's Thesis
6. Complete all coursework, the Master's Thesis, and Thesis defense within two years of their study, with an extension of up to a maximum of 4 years in exceptional cases, such as serious health problems.

The Comprehensive Exam Option

1. Complete a minimum total of 18 courses (54 credits)
2. Pass each course with at least a grade B (only three grade Cs are allowed)
3. Maintain a minimum overall GPA of 3.0
4. Complete a Master's Research Paper (MRP)
5. Sit a Comprehensive Exam (two 3-hour written exams)
6. Complete all coursework, the MRP, and Comprehensive Exam within two years of their study, with an extension of up to a maximum of 4 years in exceptional cases, such as serious health problems.

DOCTORAL STUDENTS

1. Complete 9 courses (27 credits)
2. Pass each course with at least a grade B (only three grade Cs are allowed)
3. Maintain a minimum overall GPA of 3.0
4. Complete the Doctoral Dissertation (33 credits) which comprises the following components:
 - Research Proposal defense (3 credits)
 - Publication of at least one research article (6 credits)
 - Participation (presentation) in an academic meeting or conference (3 credits)
 - Individual seminar (personal workshop) (3 credits)
 - PhD Thesis (18 credits)
 - Oral defense of the PhD Thesis
5. Complete all coursework and the Doctoral Dissertation within three years of their doctoral study, with an extension, in exceptional cases, such as serious health problems, of up to a maximum of six years of study for full-time students and 8 years for part-time students.
